How to avail:

On website:

- 2. Proceed to payments page
- 3. Confirm your details by providing your email id & mobile number as this information will be used for confirming your transaction

- 6. Click on 'Select Offer' and click on 'Axis Bank Credit Card offer' from the offers drop down list
- 7. Enter your 16 digit credit card number in the box and click on 'Check'
