



Terms and Conditions for Airport Concierge Services on Axis Bank Burgundy Private Credit Card

About the benefit:

All primary cardholders of Axis Bank Burgundy Private Credit Card are eligible for 8 complimentary airport concierge services in one calendar year.

Offer validity: This is an ongoing benefit on the card provided per year and is applicable on all active cards.

Please refer the below for details on services offered across the different airports:

Arrival (Domestic/International)

Mumbai airport:

- Warm welcome at aerobridge/bus gate by dedicated staff
- Dedicated staff for assistance from the aerobridge/ bus gate till arrival exit
- Buggy service (shared/depending on availability) from aerobridge to the immigration hall (for international arrivals only)
- Guidance with immigration process
- Dedicated porter service from baggage hall for bags (Max. 3 pieces per guest) & assistance till the arrival exit gate

Other airports:

- Warm welcome with a placard by the representative from the Aerobridge/Bus gate
- · Assistance at pre-immigration including filing of immigration form
- Buggy Service (at selected airports)
- Porter assistance for baggage retrieval and assistance (Max. 2 pieces per guest) till the arrival exit gate
- Guest will be assisted till the arrival gate or parking area

Departure (Domestic/International)

Mumbai airport:

- Warm welcome by Pranaam Officer at the curbside/car drop off zone.
- Dedicated Pranaam Officer for assistance from curbside till immigration check.
- Assistance with airline check-in process with dedicated porter for check-in baggage (Max. 3 pieces per guest) from curbside till airline check-in counters.





Guidance with the Security Check and Immigration process.

Other airports:

- Warm welcome by dedicated staff on reaching airport building
- Porter assistance for check-in baggage from curbside till airline check-in counters (Max. 2 pieces per guest)
- Assistance with airline check-in process, airport security process
- Post immigration, shall be assisted with lounge/retail
- Assisted till the designated boarding gate
- Buggy service (at selected airports)

How to avail:

- 1. Visit our curated experiences page www.extraordinaryweekends.com and choose "Airport concierge service".
- 2. Select "Book a visit".
- 3. Sign up/ login by entering your relevant information. An OTP verification would be required to login/ sign-up.
- 4. On signing in, please enter the first 6 digits of your Burgundy Private credit card.
- 5. Please enter the travel details including your time of travel, departure/arrival airport where you want to avail the services, details of guests you are traveling with and any other special requirements.
- 6. After entering all the required fields, proceed to make a Re.1 transaction using the Axis Bank Burgundy Private Credit Card to authenticate the booking.
- 7. Once the Re.1 transaction is successful, request will be submitted for processing at our end.
- 8. Service confirmation will be sent to your registered email address at least 15 hours before the travel time.
- 9. For Domestic Departures, service time will be 90 Mins prior to the flight departure time.
- 10. For International Departure service time will be 180 Mins prior to the flight departure time.
- 11. Service details along with the name of the person responsible for conducting the service will be shared 3 Hours before the service time.

*Please note: In order to facilitate this benefit, Axis Bank will be sharing customer information (i.e. name, mobile number, email address, travel details) required to facilitate the service with the service partner. Customers availing the benefit is considered to have given his/her consent for the same.

Detailed terms and conditions:

- 1. The benefit is applicable only to primary cardholders of Axis Bank Burgundy Private Credit Card.
- 2. The services offered may differ from airport to airport. Please refer to details on the booking page





- 3. Booking can also be made of guests accompanying the primary cardholder. The complimentary services eligible per customer per year will include guest visits as well.
- 4. Booking must be made at least 48 hours before the travel time to avail the services.
- 5. Cancellation: Customer can cancel the booking at least 24 hours before service time by visiting the 'Manage Booking' section on the extraordinary weekends page.
- 6. Any cancellation less than 24 hours before service time/ no show will be considered as benefit availed.
- 7. All applicable government and airport taxes will be included in the service. All additional charges such as service upgrade/ additional luggage, etc. will have to be borne by the customer.
- 8. No change in name of the passenger(s) or guest(s) from that provided at the time of booking shall be permitted
- 9. This benefit cannot be clubbed with any other ongoing offer discount/cash back/promotion.
- 10. No change or cash can be taken in exchange of the offer.
- 11. This is for personal use only, travel agents found using the services would lead to cancellation of booking and no refund would be made.
- 12. The bookings and services will be facilitated by the service partners.
