Axis Bank is authorised by Reserve Bank of India for collecting Income/ other Direct Taxes from August 2003 through its authorised Branches.

You can pay your Income / Other Direct Taxes through iConnect from your account. The payment is made by way of a Cyber Receipt, including a unique Communication Number (CIN) immediately after making the payment.

The broad process for payment, which will be initiated at NSDL Website maintaining the Tax Information Network (TIN), is as under:

- In a new browser window enter the applicable * URL, i.e. <https://onlineservices.tin.nsdl.com/etaxnew/tdsnontds.jsp> for Income / Other Direct Taxes or <https://cbec.nsdl.com/EST/InputPageForEPaymentServlet> for Central Excise & Service Tax.
- Fill up the Challan applicable for your payment with a valid PANTAN or 15 digits Assessee Code towards Income/ Other Direct Tax or Central Excise &


